He has developed many patent portfolios leading to significant license revenue and/or client acquisitions, including a billion-dollar initial public offering of a Massachusetts database technology company, and representation of a New Hampshire information technology start up during their billion-dollar private acquisition.

Before joining VLP, David was a partner at several Boston-area IP boutique firms and General Counsel of AirNet Communications, a venture funded start-up in the wireless industry.

Prior to becoming a lawyer, David was an engineer first at IBM and then at Sanders Associates (now a subsidiary of BAE Systems), where he developed digital signal processing



algorithms for the financial services and defense industries.
